- (A) Request.—An owner or operator of a vessel may request an exemption under paragraph (1), and the Secretary shall approve or deny the request by not later than 72 hours after the request is made.
- (B) PUBLIC DENIAL STATEMENT.—In any case where the Secretary denies an exemption request under subparagraph (A), the Secretary shall promptly provide a public, detailed statement regarding the reasoning and analysis for the denial.
- (C) DEEMED APPROVAL.—If the Secretary does not approve or deny a request under subparagraph (A) by not later than 72 hours after

Stafford Disaster Relief and Emergency 11 Assistance Act (42 U.S.C. 5121) on September 22, 2022 expires. 12 13 (c) APPLICABILITY.—This section, and any exemp-14 tion issued under this section, shall cease to have effect
